

Energy Bill Challenge

Terms and Conditions

This promotion has two separate components. Section A is OneBuy's prize draw. Section B is Termina's savings guarantee. They are governed by separate terms and separate parties, and should be reviewed as such.

A. Prize Draw Terms

- **Promoter:** Christian Camping International Australia (ACN 050 611 295) trading as OneBuy (ABN 74 050 611 295) of 2 Leabons Lane, Seven Hills NSW 2147
- **Promotional period:** Commences 12:01am AEST 20 July 2026 and closes 11:59pm AEST 30 September 2026 ("Promotional Period").
- **Eligibility:** Open to OneBuy member organisations, Australia-wide, who become new Termina customers during the Promotional Period. Existing Termina customers are not eligible. Limit one entry per member organisation, regardless of the number of individual signatories or sites.
- **How to enter:** Entry is automatic upon a member organisation commencing a Termina service agreement, facilitated through OneBuy, during the Promotional Period. No separate entry step, beyond the underlying Termina agreement, is required to enter.
- **Prize:** One (1) prize of \$500 AUD, paid as a donation to the winning member organisation (not to an individual). Total prize pool: \$500.
- **Draw:** The draw will be conducted electronically within 30 days of the end of the Promotion Period at OneBuy's offices. The Winner selected at random from all eligible entries.
- **Notification:** The winning organisation will be notified by phone and/or email within 2 business days of the draw. The result will also be published at onebuy.org.au. OneBuy may also publish results through newsletter and social media posts.
- **Unclaimed prize:** If the winner cannot be contacted within 14 days, OneBuy reserves the right to conduct a redraw.
- **General conditions:** The prize is not transferable or exchangeable for cash. OneBuy's decision in connection with the promotion is final. OneBuy collects entrants' details for the purpose of conducting this promotion and administering the underlying Termina member relationship, in accordance with OneBuy's privacy policy.

Prize value (\$500) is below the permit thresholds currently published for NSW (\$10,000), ACT (\$3,000), SA (\$5,000), and NT (\$5,000), and Victoria does not operate a permit system. On this basis, a trade promotion permit is not expected to be required in any state.

B. Termina Savings Guarantee

Offered directly by Termina, on the following conditions:

- The organisation is a new Termina customer (not an existing one), and
- The organisation has signed a Termina service agreement and is using Termina for energy procurement.
- **Guarantee:** if Termina has not identified savings for the organisation within the first 12 months of the service agreement, Termina will pay the organisation \$100.
- **Claim process:** the organisation notifies OneBuy or Termina in writing if no savings have been identified within the first 12 months of the service agreement; Termina then arranges payment of the \$100 to the organisation.
- **Payment:** paid to the member organisation, consistent with the draw prize. Termina, not OneBuy, carries this payment obligation and is responsible for assessing and paying any claim under it.
